Community Bank enters its 125th year from a position of strength. In 2025, the institution posted adjusted net income of \$14.4 million, executed a strategic repositioning of its securities portfolio, completed the buildout of a new Specialty Treasury Payments and Services program and expanded its mortgage lending capabilities, all while maintaining strong capital and liquidity levels.

“The investments we’ve made in people, technology, and revenue-driven strategies have laid a foundation we intend to build on,” Montgomery added. “We are committed to delivering sustainable growth by making banking simpler, faster and easier for every customer we serve, for the next 125 years.”
